On Monday, the Tenth of February Two Thousand Twenty Five (10-02-2025), we the undersigned:


**Digital Business Study Program, Faculty of Computer Science, University of Pembangunan Nasional "Veteran" Jawa Timur, Indonesia** : **Sugiarto, S.Kom., M.Kom**, in this case as **Head of Digital Business Study Program**, Faculty of Computer Science, University of Pembangunan Nasional "Veteran" Jawa Timur, Indonesia, whose address at Jalan Raya Rungkut Madya, Gunung Anyar, Surabaya 60294, and after this referred to as **"THE FIRST PARTY"**;

**Hemispheres Foundation Pte. Ltd.** : **Dr. Ann Phua**, in this case as **The Founder of Hemispheres Foundation Pte. Ltd.**, whose address at 26A Jalan Haji Salam Singapore 468810, and after this referred to as **"THE SECOND PARTY"**;

To promote human resource development through education, academic exchange, and cooperation: the DIGITAL BUSINESS STUDY PROGRAM, FACULTY OF COMPUTER SCIENCE, UNIVERSITY OF PEMBANGUNAN NASIONAL "VETERAN" JAWA TIMUR, INDONESIA, and HEMISPHERES FOUNDATION PTE. LTD., agree to sign the Implementation Agreements, details are following:

### **Article I: Purpose**

The purpose of this Implementation Agreements is to develop academic and educational cooperation based on equality and reciprocity and to promote relations and mutual understanding between both institutions.



## **Article II: Scope of the Academic Exchange and Educational Cooperation**

Parties hereby agree to cooperate in their mutual interest for a range of Higher Education and Research and Innovation activities, including - but not limited to - the following forms of cooperation:

- Student exchange programs at Bachelor levels on a unilateral and mutual basis for the purpose of education and/or research;
- Department exchange programs (short visits and short-term department exchange programs included), on a unilateral and mutual basis for the purpose of lectureship, teaching, and/or research: technical administrative and professional staff exchange programs, on a unilateral and mutual basis, for institutional capacity building and individual career development;
- Joint organization of higher education and training programs (short-term higher education and training programs included) on topics of mutual interest and invitation of each other's faculty and staff members to participate therein;
- Joint organization of seminars, conferences, or workshops on topics of mutual interest and invitation of each other's faculty members to participate therein;
- Joint application for external funding of higher education, training, and research programs and projects on topics of mutual interest, at national and international levels and invitation of each other's faculty and administrative and technical staff members to participate therein;
- Information exchange on higher education, training, and research programs;
- Information exchange on teaching, learning material, and other literature relevant to each other's educational, training, and research programs;
- Research Collaboration and International Joint Publication;
- Guiding and Examining Students' Final Assignments, Theses and Dissertations;
- Other forms of bilateral international cooperation of mutual interest.

## **Article III: Principles of Implementation**

- All specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds. Both parties can discuss getting a mutual agreement that is mutually beneficial to all parties for the cooperative activities to be undertaken as stated under the terms of this Implementation Agreements;
- The DIGITAL BUSINESS STUDY PROGRAM, Faculty of Computer Science, the University of Pembangunan Nasional "Veteran" Jawa Timur, Indonesia, and Hemispheres Foundation Pte. Ltd., should facilitate and coordinate with partner universities to implement the Implementation Agreements effectively;
- Mutual visits of lecturers/students and other collaboration plans can be discussed annually;
- Scientific research projects, jointly-held academic meetings, teaching seminars, and other agreed plans would be discussed separately;

## **Article IV: Settlement of Differences**

The differing viewpoints and interpretations of this Implementation Agreements shall be settled amicably by mutual consultation or negotiation. Both parties should facilitate the accommodation required for lecturers and students of the partner universities.

#### **Article V: Amendments, Duration, and Termination**

- Amendments to this Implementation Agreements can only be made by mutual consent for the two parties.
- This Implementation Agreements shall be in effect from the date of its signature and be valid for the duration of five (5) years from that date, and will be automatically renewed on an annual basis thereafter, unless terminated or replaced with a new Implementation Agreements.
- This Implementation Agreements may be terminated by either party by written notice at least three (3) months before the termination date. Such notice of termination will not interfere with cooperative programs currently underway. Such programs will be allowed to continue until their conclusion.

This Implementation Agreements is prepared in English and two (2) copies of this Implementation Agreements. Both copies shall be deemed authentic ones, either of which is kept by each party. As witnesses to their consent to this Implementation Agreements, the appropriate authorities hereto provide their signatures:



