# REGARDING THE INDEPENDENT INTERNSHIP PROGRAM

On Thursday, the Twenty Seven of March, Two Thousand Twenty-Five (27-03-2025), we, the undersigned:

- Agung Brastama, S.Kom., M.Kom., as the Coordinator of the Information Systems Study Program, Faculty of Computer Science, is therefore legally authorized to represent and act on behalf of the Information Systems Study Program, Faculty of Computer Science, Universitas Pembangunan Nasional "Veteran" Jawa Timur, located at Jalan Rungkut Madya, Gunung Anyar, Surabaya 60294, hereinafter referred to as the FIRST PARTY.
- 2. **Danayt Teklu**, Founder of FidelPortal.Inc, is therefore legally authorized to represent and act on behalf of FidelPortal.Inc, located at United States, hereinafter referred to as the **SECOND PARTY**.

The FIRST PARTY and the SECOND PARTY, hereinafter collectively referred to as the PARTIES, hereby agree to jointly draft an Implementation Arrangement for the Independent Internship Program based on the Cooperation Agreement executed by the PARTIES, as regulated in the following articles.

### Article 1 PURPOSE AND OBJECTIVES

(1) The purpose of this Draft Implementation Arrangement is as a basis for the implementation of cooperation arrangements drawn up by the PARTIES with reference to MOA Number:036/UN63.7/PKS/2025

(2) The purpose of this Implementation Arrangement Draft is to mutually support the activities of the PARTIES in the framework of cooperation on the implementation of the Independent Internship Program.

## Article 2 SCOPE OF ACTIVITIES

- (1) The scope of this cooperation activity includes the Implementation Arrangement on Independent Internship
- (2) **THE PARTIES** monitor the implementation of this cooperation activity at least 2 (two) times in 1 (one) year with the following scope:
  - Community Service or Field Work Practice
  - Research Collaboration
  - Independent Internship
  - Implementation of knowledge sharing activities.
  - Implementation and Development of Curriculum and Business

## Article 3 PROGRAM IMPLEMENTATION

- (1) The technical implementation of the collaboration shall be regulated by both PARTIES through mutual discussion and consensus.
- (2) The implementation of this cooperation on the FIRST PARTY involves Agung Brastama S.Kom, M.Kom, Reyza Reyznata, Najoan Rizki Pradana, and Muhammad Rafi Irsyadhie.
- (3) The implementation of this collaboration in the SECOND PARTY involves Abenezer Gebrehiwot (Abenezer@fidelportal.com)

# Article 4 RIGHTS AND OBLIGATIONS OF THE PARTIES

Rights and obligations will be discussed together according to the form and type of activities carried out and will be followed up:

#### THE FIRST PARTY

- (1) The **FIRST PARTY** becomes a partner in organizing Teaching in the fields of Education, Research and Community Service for the **SECOND PARTY**;
- (2) The **FIRST PARTY** Provides Assistance in Teaching Activities in the Fields of Education, Research and Community Service agreed by the **PARTIES** to be implemented in full;
- (3) The **FIRST PARTY** is obliged to follow all standard systems and procedures applied in the facilities and infrastructure of the **SECOND PARTY**;
- (4) The **FIRST PARTY** is obliged to maintain and care for all facilities used belonging to the **SECOND PARTY**;

- (5) The FIRST PARTY has the right to obtain facilities for some and/or all educational activities carried out at the SECOND PARTY's place according to its capabilities and in accordance with the regulations in force in the agreement of the PARTIES;
- (6) The **FIRST PARTY** has the right to obtain data and information from the results of cooperation in the context of developing education.

#### THE SECOND PARTY

- (1) The SECOND PARTY serves as a partner in conducting educational, research, and community service activities for the FIRST PARTY.
- (2) The **SECOND PARTY** shall participate fully in the educational, research, and community service activities agreed upon by both **PARTIES**.
- (3) The **SECOND PARTY** is responsible for providing the necessary facilities or resources for the collaboration activities, according to its capabilities, to the **FIRST PARTY**.
- (4) The **SECOND PARTY** has the right to reject or postpone the implementation of the "Merdeka Belajar Kampus Merdeka" education program for a specific period, provided that prior notice is given to the **FIRST PARTY**.

# Article 5 FINANCING

The costs arising from this joint activity shall be borne by each PARTY in accordance with the agreement between the PARTIES.

# Article 6 TIME PERIOD

- (1) The duration of this draft Implementation Arrangement is valid for six (6) months and may be extended for a specified period under the same terms and conditions, unless a PARTY requests a review of the terms set forth in the Implementation Arrangement in accordance with the needs and agreement of **both PARTIES**.
- (2) In the event of early termination of the Implementation Arrangement before the expiration of the aforementioned period, the terminating PARTY is required to notify the other **PARTY** in writing at least three (3) months in advance.

# Article 7 CLOSING

- (1) Amendments to the draft Implementation Arrangement may be made with the agreement of **both PARTIES**.
- (2) This draft Implementation Arrangement may be deemed null and void if either PARTY or both PARTIES fail to comply with its provisions.
- (3) Matters that are not covered or have not yet been regulated in this draft Implementation Arrangement will be determined later by the **PARTIES** through mutual discussion or consensus, which will be documented in an Addendum and shall form an integral part of this Implementation Arrangement.
